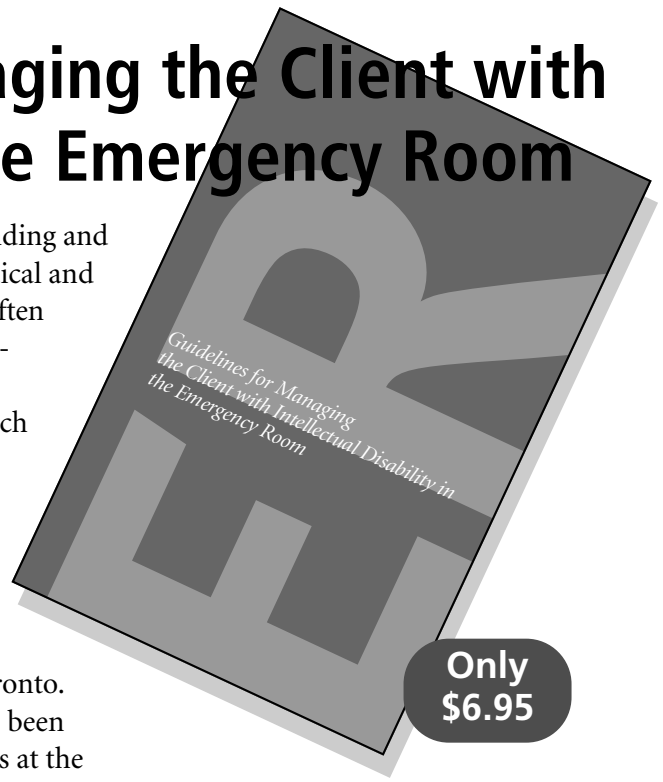
These practical guidelines will lead you to an optimal intervention when treating persons with intellectual disabilities in crisis by providing you with:
